ANNEX I: REGISTRATION FORM

1. PROJECT - THE SEABIRD-SAFE LONGLINE FISHING TOOLKIT

The 'Seabird-Safe Longline Fishing Toolkit' ('the Toolkit') is a self-funded project, developed by New Zealand¹ in Asia Pacific Economic Cooperation (APEC) Ocean and Fisheries Working Group (OFWG). It is supported by five co-sponsors economies: Chile, Chinese Taipei, People's Republic of China, Peru, and the United States.

This project will produce an information toolkit to support the tuna industry in their efforts to reduce seabird bycatch. An online industry roundtable has been organised for the 29th of November to gain key insights and input from economies and industry experts to ensure the Toolkit is fit-for-purpose.

In line with the common view of the APEC blue economy and the third economic driver of APEC Putrajaya Vision 2040, the Toolkit contributes to the OFWG's Strategic Plan 2021-2023 by improving the understanding of the oceans, marine ecosystems and their economic and social value, and promoting the blue.

2. OBJECTIVES

Consumers worldwide are becoming more aware of the environmental impacts of fishing on marine wildlife like seabirds, sea turtles, and marine mammals. High-value markets are increasingly seeking tuna with sustainability credentials, such as Marine Stewardship Council certification (MSC). Tuna fishers are responding to this demand and working to improve their practices.

New Zealand is developing the Toolkit. It aims to support the tuna fishing industry in its movement toward more seabird-safe fishing, by making accessible the essential information on practical methods to avoid catching seabirds.

The Toolkit will help build the understanding and knowledge about seabird bycatch mitigation and good practice verification. This will benefit prosperity of fishing economies by helping to secure access to high-value markets, and it will benefit marine wildlife.

The industry roundtable

The online industry roundtable is a way for the end users of the Toolkit to input into its development and provide advice to ensure the Toolkit is fit-for-purpose. The roundtable participants will be tuna longline fishing industry stakeholders who are interested in reducing seabird bycatch. The roundtable will open a dialogue between economies and industry on how the Toolkit can best benefit them.

3. DATES

The online industry roundtable meeting will be held on 29^{th} November 2023, 1:00PM – 3:30PM New Zealand time (UTC+12).

4. VENUE

The roundtable will be held online, conducted via Teams. The event organizer will send a link to the meeting and relevant login information to all confirmed attendees before the meeting.

Recording

The roundtable will be recorded by the host for the purpose of note taking. Should the host decide to publicly disseminate any part of the recording, the recording will be edited and shared with the OFWG for endorsement, as per the requirements of the APEC Project Event Recording Policy.

5. AGENDA

Key features of the roundtable event include:

- **1.** Global seabird experts will introduce the issue of seabird bycatch. International sustainable seafood industries will explain the market pressures for seabird-safe fishing, and how the tuna longline industry is responding.
- **2.** Participants will explore their interests and objectives for improving seabird bycatch mitigation and developing their fisheries businesses for shifting markets.
- **3.** The project team will present the Toolkit project and how it will help to address key challenges.
- **4.** Participants will share their thoughts on the draft Toolkit content in the three main areas:
 - i. seabird distribution mapping and important ocean areas to seabirds;
 - ii. practical measures to avoid seabird bycatch;
 - iii. practical ways to demonstrate that vessels are using the measures.
- **5.** The project team will set out the next steps for the development of the Toolkit and the opportunities for further participation in the project.

The definitive agenda including speakers will be delivered a few weeks before the Roundtable.

6. PARTICIPANTS AND SPEAKERS

All 21 APEC member economies are welcome and invited to attend and actively participate in the roundtable Meeting. There is no limit to the number of participants. Participation of qualified female participants is particularly encouraged. **Member economies are encouraged to share the invitation with relevant tuna fisheries industry that would benefit from the project.**

The Oceans and Fisheries Working Group (OFWG) may nominate appropriate expert speakers for consideration by the PO. 'Non-Member Participants', such as experts from academia, international organisations, private companies, and other independent organisation will be submitted to the OFWG members' approval, according to APEC procedures.

Appropriate expert speakers are invited by the New Zealand team.

If an economy or an industry is interested in being a speaker and sharing its

experience in seabird bycatch mitigation during the roundtable, please contact the New Zealand team.

7. METHODOLOGY

Target audience

The target audience for this project is end users of the Seabird-Safe Longline Fishing Toolkit: longline tuna fisheries compagnies and their stakeholders that are interested in seabird bycatch mitigation.

Evaluation

In this form, each participant is encouraged to share their view and advice on the meeting's impact and efficiency, as well as possible suggestions for future APEC related cooperation programs and activities.

Please also be mindful to use the correct names of the APEC economies: Australia; Brunei Darussalam; Canada; Chile; the People's Republic of China (China also acceptable); Hong Kong, China; Indonesia; Japan; the Republic of Korea; Malaysia; Mexico; New Zealand; Papua New Guinea; Peru; the Republic of the Philippines (the Philippines also acceptable); the Russian Federation (Russia also acceptable); Singapore; Chinese Taipei; Thailand; the United States of America (the USA, the US or the United States also acceptable); Viet Nam.
